Pride in WEA Membership

Everyone should be very proud of their membership in Washoe Education Association! W.E.A. has worked very hard this legislative season to keep and safeguard member's rights, benefits, and jobs.

Thanks to the hard work of your association leadership and staff who worked closely and continuously with Washoe County School District, a number of very positive things stayed in place. First and most importantly there will be no lay-offs or Reductions in Force (RIF) in our district. At the end of the school year, everyone with a standard contract who stayed in the district and did not retire will have a job! Second, Washoe County teachers and education employees will keep their salary schedule, steps, and "roll-overs" in tact! There will be no "step freezes" nor salary percentage decreases as per the recommendation of Governor Gibbons. Washoe county educators will be the only group in the state of Nevada, outside of the two major Nevada gold producing counties, that will not experience those cuts to salaries or jobs! This took a lot of hard work and many conversations between WCSD and WEA.

NSEA, WEA, and its members sent over 15,000 letters and postcards to their legislators protesting Governor Gibbons' drastic cuts to education. WEA and its members sponsored a rally April 13th in Carson City, attended by hundreds of educators, urging the legislature to do the "right thing" for public education and restore funds to education that were cut by our "Education First" Governor. We strongly sup-

ported our legislators in restoring over \$300 million to the education budget through revenue enhancements. These actions helped save salary schedules, Regional Professional Development centers, health insurance funding, adult education, and the 1/5th service credit in Nevada and WCSD. Another victory we can be proud of is the successful passage of the Room Tax Initiative during the November elections. Guiding the room tax through the legislature, to the governor's desk, and into law was a major accomplishment that will add approximately \$200 million to the state's budget. Again, your state and local associations' hard work and the hard work of all members made this a reality.

The next time you hear someone ask what advantages there are to belonging to WEA, your professional association, and what WEA does for its members, just point to this article and then to your paycheck. Point out that there were no lay-offs or Reductions in Force, and that we are the only county in Nevada, other than the two "gold counties," that did not experience these painful processes. WEA and its members have much to be proud of this year! Our members were active, vocal, and very involved. That is what makes this association one of the strongest in Nevada, what makes us effective, and why we are proud members of WEA! Thank you members for all your hard work! I am proud to be your WEA President!

Final Report on the Legislative Session

Legislative Update

Thanks to your postcards and e-mails, the NSEA Lobby Team, and the Legislators, nearly \$300 million dollars was returned to the K-12 budget that was scheduled for nearly \$700 million dollars in cuts from the governor's budget. Included in this was health insurance, money for professional development, and adult education, and for those who chose the "credit" instead of the cash, the 1/5th service credit was continued until those currently enrolled gain the maximum one full year.

Although the Legislature did reduce the amount of money that WCSD will receive, the district - thanks to Superintendent Dugan, staff and the Board of Trustees - had begun cost saving measures last year continuing to this spring, enabling the use of the ending fund balance to keep the "contract" intact. WEA took the position early on, and the superintendent agreed, that we had a contract that was in force and that changes would require negotiations, which the district wanted to avoid.

The bills enabling the "revenue enhancements" will sunset in two years, meaning that the next legislative session could easily be as difficult as this one unless there is a governor who is

not handcuffed by ideology and a legislature just as willing to try to find solutions.

The passage of the bill that came from the NSEA initiative petition (IP 1 became law without the governor's signature) that equalizes the hotel room tax is expected to bring in \$200 million. This was a huge win for WEA and NSEA and allowed us to remind the legislators that teachers brought \$200 million in revenue to the table.

Other Major Bills Relating to Education

AB 243 requires employers to grant leave to a parent, guardian or custodian of a child to participate in certain school conferences, activities, and events.

AB 488 extends to June 20, 2015 the program that allows retired educators to fill critical labor shortage position and collect PERS. It also allows an easier process for the district to designate a critical labor shortage.

SB 163 defines "bullying" and "cyber-bullying" and revises the provisions governing safe and respectful learning environments to include a prohibition of these acts. Penalties for bullying have been in law previously, but the term had never been legally defined.

SB 416 suspends, for the next two

years, norm-reference examinations. It also prohibits school districts from administering any district-wide test not adopted by the school district before July 1, 2007, and is not required by state or federal law.

SCR 37 requires the Interim Finance Committee to conduct a review of Nevada's revenue structure and to provide long-term stabilization of revenue.

As in many past legislative sessions, bills that were stopped were as important as those passed:

- There were changes made to PERS and PEPB, but ONLY for new employees hired after January 1, 2010.
- Bills were fought that would have made major changes to collective bargaining
- Bills that would have tied teacher evaluations to student test scores
- Bills to enact blatant anti-union measures
- A bill to provide vouchers to students to attend private schools

Bills that were supported by educators, but were vetoed were **AB 319** (Educators Bill of Rights), **AB 422** (excluding School Support Taxes from the STAR bonds), and **AB 458** (establishing an education stabilization fund).
